**Guidance Notes for the completion of this application form**

1. Applicants should note that unless all Sections of the form are completed accurately, the Aircraft Registry will not be able to process the application. In this event the applicant will be notified accordingly and the application form will need to be re-submitted. Surveys will be carried out Monday to Friday unless it is a public holiday – please refer to our [website](#) for a complete list of public holidays.
2. The aircraft TCDS is the Type Certificate Data Sheet that the IOMAR has carried out all Airworthiness Surveys against whilst the aircraft has been IOM registered, the Export C of A will confirm compliance to this TCDS on successful demonstration of the applicable standard.
3. The survey will take place to sample the aircraft documents back to the last C of A carried out by an IOMAR surveyor. Refer to [RP17](#) for guidance.
4. An Export C of A can only be issued to aircraft that hold a current C of A issued by IOMAR.
5. If a C of A has been issued within 60 Days of requesting an Export C of A then an Export C of A Certificate can be issued without further attendance from the IOMAR. Please note the Export C of A will have the same issue date as the C of A. **In the event this is required, when submitting the Form 10, only complete sections 1, 2 & 5 and enter 'N/A' in the row titled Name (presenting aircraft). The IOMAR reserves the right to perform an Export survey if deemed necessary.**
