4. INSTRUMENT

This instrument is an Irrevocable De-registration and Export Request Authorisation issued by the registered owner in favour of the Authorised Party identified at Section 3 (i.e. the creditor) under the authority of Article XIII of the Protocol to the Convention on International Interests in Mobile Equipment on Matters Specific to Aircraft Equipment. In accordance with that Article, the undersigned requests:

- i. Recognition that the Authorised Party referred to above or the person it certifies as its designee is the sole person to:
 - a. Procure the de-registration of the aircraft from the Isle of Man Aircraft Register maintained by the Isle of Man Aircraft Registry for the purposes of Chapter III of the Convention on International Civil Aviation, signed at Chicago, on 7 December 1944, and
 - b. Procure the export and physical transfer of the aircraft from the Isle of Man; and
- ii. Confirmation that the Authorised Party or the person it certifies as its designee may take the action specified in clause (i) above on written demand without the consent of the undersigned and that, upon such demand, the authorities in the Isle of Man shall co-operate with the Authorised Party with a view to the speedy completion of such action.

The rights in favour of the Authorised Party established by this instrument may not be revoked by the undersigned without the written consent of the Authorised Party.
